The undersigned exhibitor applies for exhibition space at the above-named show and encloses payment herein.

The Exhibitor Understands and Agrees as Follows:

Admission is limited to one exhibitor and one named helper. Exhibitors must provide their own table covers. All exhibitors are required to collect sales tax for all retail sales. Exhibitors are required to have a NJ Sales Tax Certificate.

The exhibitor agrees to fulfill all municipal, state, and federal regulations in regard to taxes, sales, and safety.

Vintage Castings, Inc (VCI) has full authority over the placement, arrangement, and appearance of all space at the show. VCI may alter the exhibitor's location of sales space as shown on any floor plan. Exhibitors may not use tables or boards to extend the surface area of his table(s). Exhibitors may not put goods in the aisles either in front of or alongside his table(s). For insurance and safety concerns, all exhibits are limited to a maximum of four feet above table height.

Management reserves the right to direct an Exhibitor to remove any item(s) management feels are in poor taste. Management reserves the right to immediately remove any vendor refusing to abide by all and any rules & regulations related to the proper functioning of the show, or agreed upon by signing this contract, with complete loss of table rental fees.

VCI retains the right to reject, eject, or prohibit any product or exhibit in whole or in part. VCI retains the right to reject or eject an exhibitor or his representative(s) with or without giving cause. Exhibitor warrants that exhibitor carries vehicle liability insurance for any vehicle that is brought onto the facility premises.

Exhibitor releases VCI from all claims arising from exhibitor's show occupancy, including but not limited to loss, theft, damage, destruction, or injury to exhibitor's business. Exhibitor releases VCI from all claims arising out of VCI failure to provide space, removal of exhibitor, or failure to hold the show.

Exhibitor hereby contracts for exhibition space at the 37th Annual East Coast Toy Soldier Show and agrees to release Vintage Castings, Inc. and Farleigh Dickinson University from any damage or loss whatsoever and from all liability for personal injury to himself, his associates, and/or his merchandise and further agrees to defend and indemnify or hold harmless Lee Berman, Karin Lango Berman, Janice Lango, Vintage Castings, Inc./and FDU in the event of a suit or claim.
